You can apply for free school meals if you and your child(ren) live in the borough. You must get one of the benefits listed over the page and receive child benefit for the child(ren) you are applying for.

If your child gets a free school meal the school will get additional funding known as a pupil premium. This money helps the school improve the education they provide.

Qualifying Benefits

To get free school meals for you or your child, you or your partner must get one of the following:

- Universal Credit
- Income Support (IS)
- Income Based Jobseekers Allowance (JSAIB)
- Income Related Employment and Support Allowance (ESAIR)
- The Guaranteed element of State Pension Credit
- Support under Part VI of the Immigration and Asylum Act 1999
- Child Tax Credit (but no entitlement to Working Tax Credit) and your yearly income is less than £16,190
- Child Tax Credit and Working Tax Credit where your Working Tax credit has continued for a four week period after your employment finished, and your yearly income is less than £16,190

You do not need to provide proof of your qualifying benefit as we will check your entitlement using a secure government website

If you are a child and get Income Support, Income Based Job Seekers Allowance or Income Related Employment and Support Allowance for yourself you can apply for your own free school meals. Please complete this form and put your own details in all the sections.

Other help is available for pupils aged 16 to 19 in full time education. If your child is struggling with the costs of learning they should speak to student services at their school, college or training provider for more information. Or contact Positive Steps free on **0161 621 9300**.

Universal Infant Free School Meals

From September 2014 all children in Reception, Year 1 and Year 2 in state funded schools in England are eligible for Universal Infant Free School Meals. This includes academies, free schools, pupil referral units and alternative provision as well as maintained schools.

They are available regardless of their parent's or guardian's income. If you do not get one of the qualifying benefits for free school meals, please contact your child's school if you want them to get a Universal Infant Free School Meal instead.

Refunds – If we award free school meals for a period of time you have paid for, you must contact the school for a refund.
